COUNTRYSIDE STEWARDSHIP HIGHER TIER


From September 2025, applications will open for the Countryside Stewardship Higher Tier (CSHT) scheme for those who have been invited to apply and already completed the pre-application process and any preparatory work.

This forms part of the government's investment in sustainable farming and food production during this parliamentary term. Within this, funding for nature-friendly farming, including Environmental Land Management schemes such as CSHT, will rise to £2 billion by the 2028/29 financial year.

The new scheme includes several improvements aimed at making the process more accessible and supportive for farmers and land managers. These include a rolling application window, quarterly payments and a simplified online application. For more information click here.

WATER NET GAIN PROJECT

Water Net Gain is a catchment-scale approach whereby farmers are paid to store water on their land.

Creating additional ponds and reservoirs means water can be used on-farm or actively released into rivers and streams to improve flows during droughts.

This research project is being piloted across catchments throughout the country, but will be coming to the Mersey Basin this autumn, mainly focusing on the Downholland Catchment on the Alt.

UPCOMING DATES FOR THE DIARY

1st September - For any land located in a Nitrate Vulnerable Zone (NVZ), this is the start of the closed period for applying organic manure with a high readily available nitrogen content to grassland on shallow or sandy soils and for any land located in an NVZ and applying manufactured nitrogen fertilisers to tillage land.

15th September - For any land located in an NVZ, this is the start of the closed period for applying manufactured nitrogen fertilisers to grassland.

16th September - For any land located in an NVZ, this is the start of the closed period for applying organic manure with a high readily available nitrogen content to tillage land on shallow or sandy soils that have been sown with crops on or before September 15th.
